Mr. Jeffrey Deeds, Visconsi Companies, Ltd., 30050 Chagrin Blvd., Pepper Pike, OH is representing the application for the new bank building located at 4015 Erie St., Willoughby, OH.

Mr. Deeds thanked the Board for holding a special meeting. He stated they were tabled at the last meeting

so they could make some changes to the exterior of the building; but there were no issues with the site plan. The bank, on their original plan, had signage on the corner of Erie St. and Mentor Ave. The city has asked the bank for an easement on that corner to allow for some artwork and landscaping that the city would maintain (this is shown on the hatched area on the plan). They currently do not have an agreement for the easement, but will negotiate in good faith as long the bank is able to determine a reasonable size for the artwork and improvements. In lieu of not having their sign on that corner, they would like two signs at each entrance of the bank.

Mr. Kary asked if the bank would be willing to replace the two existing light poles with the historic style light poles that are in the downtown area. Mr. Deeds stated he would commit to two historic light poles along the sidewalk, but not within the parking field due to federal regulations.

Mr. Deeds stated they came up with new renderings as a result of the work session last week. They have changed the water table to brick on the east side and around the entrance. They were also before the Design Review Board (DRB) last night and the DRB had requested they add more brick to the base under the coping on both the north and south elevations, which they have done (new renderings in record). The Planning Commission Board agreed and liked the addition of the brick. Mr. Deeds provided brick and siding samples for the Board to view.

There was some discussion on the south landscaping line. Mr. Deeds clarified that the red twig dogwood are shrubs that would have nice red twigs in the winter and would lend to the landscape once the leaves have fallen off.

Mr. Kary moved to approve the Development Plan/EAS for the new bank building located at 4015 Erie St., Willoughby, OH 44094 as submitted and Mr. Merhar seconded.
