Notice is hereby given that the Council of the City of Willoughby, Lake County, Ohio, at the Regular Council meeting held on April 2, 2019 passed the following:

### RESOLUTION NO. 2019-23

A resolution approving EAS #1-2-19 for the rezoning of .4158 acres of real property located on the corner of SOM Center Road and Willow Creek Place and further identified as a portion of Permanent Parcel No. 27A0060000380 from Residential One-Family 100 (R-100) to Residential One-Family 60 (R-60).

### ORDINANCE NO. 2019-24
