## SOM PAVING PROJECT

ODOT project to repave SOM from the County Line (south end of Willoughby Hills) to Route 2 (north end of Willoughby) is starting this month and will not be complete until mid November. Expect traffic delays and quite a mess for the next couple months. The schedule shows them starting at the South end and we may not see activity in our direct area until the 3rd week of September. Special plans being made to try and mitigate impact in the very high traffic area between Ridge Road (RT 84) and Halle Drive.

## SCHOOL ZONES - Flashing Lights

A new School Zone with flashing lights is up and operational in front of the new Tech Center on Euclid Avenue. The Zone on SOM has new signage and poles are up but the lights did not arrive in time for the first day of the new school year. The flashing lights should be installed and operational in the next couple of weeks. Many of you mentioned the dangers last year with many drivers not paying attention to the signage so flashing lights should have a positive impact.

## SOM PROPOSED DEVELOPMENT Senior Citizen Development

After having gone quiet for about 6 months, the project is back on the table with a formal application to move forward. As a reminder, this is the large wooded parcel on the East side of SOM, just to the South of the new entrance drive to Edison Elementary and the new homes being constructed by Knez Homes. Those of you within 300 feet of this parcel have already received legal notice of a Public Hearing scheduled with Planning Commission for September 8th. The Public Hearing will be at 7 p.m. in City Hall Council Chambers. The project is proposing Text Changes as well as a Lot Split. All are invited to attend and offer input. Vista Springs is the developer with a similar property in Macedonia. Site plans show an Assisted Living with Memory Care unit in the front parcel (facing SOM) and a Skilled Care Nursing Facility towards the back of the property backing up to Ridge Acres. It is my understanding that the Skilled Care unit will be a joint venture with Lake Hospital and act as a step down facility for post Hospital stays.

## OSBORNE PARK IMPROVEMENTS

Plans have been finalized and contract awarded for improvements to Osborne Park along Lake Erie. A new walking trail circling the property (approx. 1.3 miles) will be constructed along with a new access drive off of Eaglewood. The new access will go to parking on the North end of the park with Lakefront Access and will include a new pavilion, benches and playground equipment. Plans to start soon and the path will be completed this fall.
