Mr. Carr asked about a pipe that was on backorder for a project. Mr. Lannon said that pipe was for Topps Industrial Parkway; the pipe for that outfall project is in and almost complete.

<u>Fire Chief Ungar</u> – Chief Ungar said he was happy to report there were no injuries at an accident that took place yesterday at the end of Lost Nation Road. However, the front of the building did sustain pretty significant damage. The East Side Technical Rescue Team was called in to shore up the remaining portions of the building.
