Westel's Alibi & Hush 4084 Erie St. (Rep.- Thomas Gerbic, Owner) New garage door style window

Mr. Gerbic, Owner of Westel's Alibi & Hush, 4084 Erie St., Willoughby, OH 44094 is representing his application.

Mr. Gerbic said they are proposing to put a garage style door in where the front window is currently located.

Vice Chairman Garcia said the application is pretty straight forward and he likes the submittal, as long as everything matches.

Mr. Volpe said he would like to see a detailed drawing of what they are proposing. He said there are three different style garage doors in the downtown area. Mr. Gerbic said the drawing they provided was a generic CAD system drawing from the door company. He said the drawing shows frosted glass and it does not have frosted glass. He said their number one priority is that the door maintains a similar look to the building. He said they used the garage door style from Nickleby's as an example when they showed their carpenter. He said it will have matching trim made out of either metal flashing or Trex material made to mimic what is currently there. Mr. Volpe asked about the side window. Mr. Gerbic said the side window will stay. Mr. Volpe said he has worked on many storefronts, and he went by Westel's, and noticed the lower bulkheads were a little rough, but they have a nice transom system.

Mr. Henrich asked for clarification that the glass will be clear with no tint and Mr. Gerbic said that was correct.

Vice Chairman Garcia asked if the sections/partitions in the rendering will be similar with eight sections and Mr. Gerbic said yes, it is predicated by the size of the door.

Mr. Henrich moved to approve the replacement of the existing front window with a new garage style door, for Westel's Alibi & Hush, 4084 Erie St., Willoughby, OH 44094 as submitted and Mr. Brown seconded.

Young Sushi
12 Public Square

Awning over patio area

(Rep.- James Lee, Owner)

Mr. Lee, Owner of Young Sushi, 12 Public Sq., Willoughby, OH 44094 is representing his application.

Mr. Lee said he wanted to add an awning over their front patio. He said he provided a sketch from the contractor. He said, with the pandemic, they will have a lot more people that will want to sit on the patio. He said their patrons have complained that the umbrellas they provided previously didn't shield them from the sunlight or if it was a windy day the umbrellas would fall over. He said he would like to get started early, so it will be ready for summer.

Vice Chairman Garcia asked if the awning will be year-round. Mr. Lee said he is a bit concerned about it being up all year and the awning company does provide a service where they would come out to remove the awning through the winter months. He said his father was not in favor of removing the awning and would rather make the structure more stable to support the snow load and have it up year-round. He said if they do not feel it is not sturdy enough they will have them remove it for the winter months. He said his father visited several sites that have this type of awning and said they lasted through the winter months without an issue.

Vice Chairman Garcia said he thinks having just the support structure standing alone through the winter months would not look good. He asked if they would integrate the structure with the fencing so it would all look the same and Mr. Lee said yes.

Mr. Henrich asked if there will be fabric over the support structure. Mr. Lee said yes, it is a specialized fabric that is water and wind resistant. Mrs. Grinstead said the samples glued to the application feel like a vinyl like fabric.

Vice Chairman Garcia said he prefers the structure to be permanent. Mr. Lee said they will install it in 6-8 weeks from this approval.

Mr. Henrich said he is concerned about the fabric and wondered if there would be a better option such as a metal type product for the snow load. Mr. Volpe said the awning company is a reputable company and he does not have an issue with it. Vice Chairman Garcia said there are two colors presented on the application, black and burgundy, and asked which would be the color. Mr. Lee said he prefers burgundy. Mr. Henrich said he saw a note on the rendering that said the wind load was 110 mph and the awning would support loads of 34 lbs. per square foot and was satisfied it would be sturdy enough.

Vice Chairman confirmed that burgundy will be the color of the awning and Mr. Lee agreed.
