City of Willoughby Board of Zoning Appeals Public Hearing Meeting Minutes July 13, 2022

Chairman Palmer stated the applicant cited practical difficulty numbers 1, 2, 3, and 8 on the application for appeal and noted all items that were in the packet.

Chairman Palmer asked if anyone wished to speak for this appeal. Cione Belknap of Agile Sign & Lighting, 35280 Lakeland Blvd., Eastlake, OH 44095 agent for Northcoast Memorials, 4490 Beidler Rd., Willoughby, OH 44094 was sworn in to speak for the appeal.

Ms. Belknap said she explained to her client that they were not considered a corner lot and are next to a railroad. She said where the sign would normally be allowed, this size sign would not fit and believes it would be a visibility issue for the company's clients. She said a lot of their clients are coming in off the freeway and would not be able to see the sign and drive past the building and have to turn around. They currently have a small granite monument sign which is not that noticeable. She said the reason she chose practical difficulty number one special circumstances is because the building is very narrow, and it would be hard to see the sign on the front façade coming over the railroad tracks.

Chairman Palmer asked if this sign was illuminated, and Ms. Belknap said it is not. She said they reduced the size of the sign and also made it non-illuminated when they found out they needed to obtain a variance. The client feels it would look too cluttered on the front façade of the building and this size would not be able to be anchored properly. They felt it had a better overall aesthetic on the side of the building. Chairman Palmer said he feels that the same size sign on the front façade would be just as noticeable and would not require an appeal.

Mr. Davis said if deleted their logo the sign may fit better on the front façade. Mr. Maniche said he also feels the sign would fit on the front façade and agrees with Mr. Davis. Chairman Palmer suggested submitting a rendering showing the sign on the front façade as well, so the board can see both options.

Ms. Belknap asked to have her appeal tabled, so she can confer with her client regarding the placement of the sign.

Mr. Maniche moved to table this appeal per the applicant's request for Northcoast Memorials, 4490 Beidler Rd., Willoughby, OH 44094 and Mr. Davis seconded.
