Mr. Garcia moved to approve (1) illuminated ground sign for the Trinity Lutheran Church, 37728 Euclid Ave., Willoughby, OH 44094 and Mr. Brown seconded.

Ms. Ruff of Ruff Neon & Lighting is representing this application for (1) illuminated ground sign.

Chairman Perkovich advised Ms. Ruff that there are only three of the five members present this evening and she needs all three members to vote in favor to pass her proposals and she wished to proceed.

Chairman Perkovich expressed his approval of the revised submission and requested details on its nighttime appearance and asked about adding a dimmer. Ms. Ruff explained that the sign would feature a soft glow across the face and agreed to include a dimmer. Mr. Brown concurred with the updated design. Mr. Garcia also supported the proposal and requested a timer, which Ms. Ruff agreed to add. The Board stipulated that the sign be turned off daily from midnight to 6:00 a.m.

Chairman Perkovich noted that if these conditions present any issues for the church, they may return to the board for reconsideration.

Mr. Garcia moved to approve (1) illuminated ground sign for the Trinity Lutheran Church, 37728 Euclid Ave., Willoughby, OH 44094 as revised (11/6/25 rendering) and with the stipulation that a dimmer and timer are added and that the sign be turned off daily from midnight to 6:00 a.m. and Mr. Brown seconded.

Ms. Ruff stated that the window signs will be vinyl decals positioned lower on the glass for visibility beneath the awning. The 'Jackpot Go DTW – Late Night Eats' decal will be applied to the door.

Chairman Perkovich noted the signs include a shadow element and that the largest measures approximately two feet square, presenting a nondescript design. No additional comments or questions were raised by the board.


Chairman Perkovich noted there were two typos that have already been corrected.


Mr. Garcia moved to approve the DRB minutes of November 5, 2025 as amended and Mr. Brown seconded.
