Potential capital improvements

Chairman Norris said Planning Commission is charged via city charter to recommend any potential capital improvements each year. He then asked the commission if any member had any suggestions. Chairman Norris suggested two items: 1) Install patron protection for outdoor dining in downtown Willoughby. It would protect the city from liability issues if they installed vehicle barricades, 2) Have a study done for a potential roundabout at Lost Nation and Hodgson Rd. in lieu of a traffic light and could save the city quite a bit of money.

Mr. Kary said there will be a traffic study done from Adkins to Lakeshore Blvd. by Mr. Lannon of CT Consultants. He said it is two miles without a traffic light. There is a significant cost to install a traffic light at Hodgson and Lost Nation Rd. Mr. Kary said the cost to widen Hodgson and install a traffic light could be anywhere from \$500,00 to \$750,000.
