Chairman Norris asked if there was anyone that would like to speak in favor of the proposal.

Ms. Landgraf, Esq. stated for the record that only a portion of parcels 27-A-015-0-00-018-0 and 27-A-015-0-00-017-0 will be rezoned, and the other two parcels will be rezoned in their entirety.

Mr. Sommers said he met with the Board a few weeks ago for an informal discussion and wanted to discuss some items that were brought up. He said the previous YMCA building that is no longer in use, used to average over 1,600 people a day using the facility. The footprint for Aldi's will only be approximately 12,000 square feet of usable retail space and generate significantly less traffic than most grocery operations. He said it is in the heart of the retail corridor and is an appropriate and consistent use in this location. He said he received a few letters with concerns regarding traffic, and as stated above, there will be less traffic than the previous company. He said there were a few issues regarding police and fire response time. He said they are close to both police and fire departments and there is a signal at the intersection for the emergency vehicles and does not believe it will be an issue. He would like Mr. Pychewicz, Engineer for Aldi's to address some of these issues regarding traffic. He said there was mention in the letters of light and noise pollution. He said Aldi's is a nationwide company and is cognizant of the surrounding neighbors. He said, for example, they use LED energy efficient down lighting. They only average two deliveries a day which are done during business hours.

Mr. Sommers said, for the record, they did submit, per the request of Planning Commission, the release of deed restriction.

He said he knows there are concerns regarding the traffic generation, especially with the schools. He said the trip generation of an Aldi is fairly low in comparison to most grocery stores. He said most traffic is generated on the weekends when school is not in session.
