Mr. Belknap of Agile Sign & Lighting is representing the sign package for UH Rainbow Babies & Children's Perrico Health Center.

Chairman Koskovics said there are three signs; (1) illuminated wall sign and (1) non-illuminated freestanding ground sign w/id and (1) illuminated freestanding ground sign and suggested the board vote on this application as a package. He said this is an amended submission that was previously approved by this board.

Mr. Belknap said the hospital has decided to add Rainbow Babies and Children's to the previously approved signage. He said the directional sign they made larger but did not want to seek a variance, so they changed it to fit within the allowable square footage. The main ground sign remains the same with the exception of adding the additional copy of Rainbow Babies & Children's with the logo.

Chairman Koskovics asked if there is currently ground cover at the base of this illuminated freestanding ground sign and Mr. Belknap said yes there is. The board had no questions or concerns on this application.

Mr. Phillips moved to approve (1) illuminated wall sign and (1) non-illuminated freestanding ground sign w/id and (1) illuminated freestanding ground sign. for UH Rainbow Babies & Children's Perrico Health Center, 4176 S.R. 306, Willoughby, OH 44094 as submitted and Mr. Shannon seconded.


February 28, 2022

Ms. Ward moved to accept the SRB meeting minutes of February 28, 2022 as submitted, and Mr. Shannon seconded.


