Ms. Nichols of LAAD Sign & Lighting, 3097 S.R. 59, Ravenna, OH 44266, is representing the sign application for PNC Bank.

Chairman Koskovics suggested the Board vote on this application as a package. He noted that there was an addition to the application of the illuminated monument sign.

Chairman Koskovics noted that on the applicants site plan they had the city as Willoughby Hills instead of Willoughby.

Chairman Koskovics said PNC bank will be removing the existing wall signs and replacing them with (3) new illuminated wall sign for the south, east and west elevations. Ms. Nichols said there was an error or their applications and these three signs are non-illuminated. They are cut out aluminum letters that are ¼" thick and are flush mounted. It does say they are non-illuminated on their site plan. Mr. Popelka asked if the building will be cleaned and painted. Ms. Nichols said they will be cleaning and painting the building before installing the new signage.

There were no questions from the Board on the (1) non-illuminated instructional sign for the night deposit box, or the (3) non-illuminated directional signs for drive up services, customer parking only and disabled only sign, (1) non-illuminated glass door decal for PNC Bank and hours insert, or the (1) non-illuminated instructional window decal for the teller window.

Chairman Koskovics said the last item was the illuminated monument sign added to the packet. He said this monument sign will be replacing the existing pole sign. Ms. Nichols said she will have to work out some details with the Building Department as to the exact location they can install the monument sign as far as the right-of-way. She said the existing pole sign is currently on the edge of the property. She believes the road was widened at some point and would have to go out to the site and obtain some measurements. She understands there is a required setback for the monument sign. She also has drawings provided to them by the Building Department, but will need assistance in determining where to install this sign for the proper setback.

Mr. Phillips moved to accept the sign application package as submitted for PNC Bank, 35091 Euclid Ave., Willoughby, OH 44094 with the stipulation that year-round ground cover is required at the base of the monument sign and Mr. Shannon seconded.
