Mr. Yankovich of Ellet Neon Sales & Svc. is representing the sign package for Club Pilates.

Mr. Yankovich said they are requesting channel letters and a logo. This business is a franchise and have the same type of sign at every location. The letters are 13" high and the logo is 19 ½" high and are on a white background. The letters are front lit, and halo lit; they are black during the day and illuminate white at night. The letters stand off the white backer 1 ½" and the back is illuminated blue; blue LEDs on the back and white LEDs on the front. During the day it would be white and in the evening it would blue. Ms. Ward asked if the blue was just the outline of the sign, and the rest is white, and Mr. Yankovich said that was correct.

Mr. Yankovich said the other sign they are requesting are face replacements for the existing ground sign. They are 17" high and 69" wide and are a flat plastic with black vinyl letters and will illuminate white in the evening.

The board members had no questions or comments.

Ms. Ward moved to accept the sign application as submitted for (1) illuminated wall sign and (1) illuminated existing freestanding ground sign with new panel insert for Club Pilates, 5872 SOM Center Rd., Willoughby, OH 44094 and Mr. Shannon seconded.



Mr. Shannon moved to accept the SRB meeting minutes of March 14, 2022 as submitted, and Mr. Phillips seconded.


