Vice Chairperson Ward asked if Mr. Detar had any color renderings of the menu board and he said he did not, he only had the shop drawings which is what the board is viewing. He said his client did not give them color renderings. Vice Chairperson Ward said she would assume this would be Chick-fil-A's branding standards. Mr. Detar said he really did not look at this one much. They do not really even call out colors. The structures themselves are a bronze color.

Vice Chairperson Ward asked if the board will be digital. Mr. Detar said he did not believe so. He said there is LED and strip lighting which would not be behind a LED screen. Vice Chairperson Ward asked the board if they had any concerns approving this without having color renderings. The board members did not have any questions or concerns.




Mr. Phillips moved to accept the SRB meeting minutes of September 12, 2022 as submitted, and Mr. Shannon seconded.
