**Dukes N' Boots** 4027 Erie Street Sign projection from building and projection over the right-of-way

(Bruce Vargas, Owner and James Vacey, Signature Sign Co.)

Chairman Palmer stated the applicant cited practical difficulty numbers 3 and 4 on the application for appeal and noted all items that were in the packet.

Chairman Palmer asked if there was anyone who wished to speak for this appeal. Mr. Vacey of Signature Sign Co., 1776 East 43rd St., Cleveland, OH 44103, agent for Dukes and Boots was sworn in to speak for this appeal.

Mr. Vacey said they are before the board tonight seeking approval for their projecting sign for their new establishment. He said himself, the owners of the building and their architect feel the sign fits the aesthetics of the building. He said they are over the allowable 5' limit by 10". He said the city allows 2' from the building in the right-of-way. He said the building sticks out and does not leave much room for a sign.

Chairman Palmers concern is if the business does not thrive and possibly closes who will take down the boot. He said it would be the responsibly of the owners to take it down and would possibly be read into the motion.

Mr. Yutzy said this sign does not stick out any further then the DavEd Jewelers sign. The right-of-way issue is because they lose a lot of the frontage due to the turning lane.

Chairman Palmer asked if there was anyone else who wished to speak for this appeal. Mr. Vargas, Owner of Signature Sign Co., 1776 East 43rd St., Cleveland, OH 44103, agent for Dukes and Boots was sworn in to speak for this appeal.

Mr. Vargas wanted to point out the size of the sign is within the code and it is modest overall for the building. He said the boot tip is the issue.

Chairman Palmer asked if there was anyone else who wished to speak for this appeal (x3) and there was no one.

Chairman Palmer asked if there was anyone who wished to speak against this appeal (x3) and there was no one.

Mr. Yutzy moved to grant a variance to C.O.1163.06(c) to allow a sign with a 5'10" projection exceeding the allowable by 10" and exceeding the allowable right-of-way by 3'10" instead of the allowable 5' projection from the face of the building and no more than 2'over the right-of-way; citing C.O. 1109.09(b) for Dukes N' Boots, 4027 Erie St., Willoughby, OH 44094 and Mr. Maniche seconded.
