A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO AN EIGHT (8) YEAR LEASE PURCHASE AGREEMENT WITH LEASING 2, INC. FOR ONE (1) 2025 E-ONE HR 100 SINGLE AXEL AERIAL TRUCK FOR USE BY THE WILLOUGHBY FIRE DEPARTMENT, AND DECLARING AN EMERGENCY.

WHEREAS, the City received a quote and thereafter entered into a purchase agreement in the amount of \$1,413,344.00 with Advantech Service and Parts, LLC through the State of Ohio Cooperative Purchasing Program for the purchase of one (1) 2025 e-One HR 100 Single Axel Aerial Truck for use by the Willoughby Fire Department; and

WHEREAS, it is in the best interest of the City to now enter into a eight (8) year lease purchase financing agreement for the 2025 e-One HR 100 Single Axel Aerial Truck with Leasing 2, Inc;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WILLOUGHBY, THE COUNTY OF LAKE, AND THE STATE OF OHIO:

SECTION 1. That the Mayor is hereby authorized to enter into an eight (8) year Lease Purchase Agreement with Leasing 2, Inc., 1720 West Cass Street, Tampa, FL 33606-1230 for one (1) 2025 e-One HR 100 Single Axel Aerial Truck for use by the Willoughby Fire Department commencing August 20, 2023.

SECTION 2. That the Mayor is further authorized to execute any and all additional documents and forms necessary to the implementation of said agreement.

SECTION 3. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were conducted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such actions were conducted in meetings open to the public in compliance with all legal requirements including Chapter 107 of the Codified Ordinances of the City of Willoughby.

SECTION 4. That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, and welfare of the inhabitants of the community; and for the further reason to implement production of the Aerial Truck immediately; and provided that it receives the affirmative vote of two-thirds of the members elected to Council, it shall be in full force and take effect immediately upon its adoption by Council and approval by the Mayor; otherwise, it shall be in full force and take effect from and after the earliest period allowed by law.
