RESOLUTION NO. 2026-20

A resolution approving EAS #2-1-26 for construction of a gas station and convenience store located at the corner of Lost Nation Road and Tamarac Boulevard (Tamarac Gas Station).

RESOLUTION NO. 2026-21

A resolution expressing an intent to sell unneeded, obsolete, or unfit property by internet auction, establishing a procedure for conducting the sale, and declaring an emergency.

ORDINANCE NO. 2026-22

RESOLUTION NO. 2026-23
