

RESOLUTION NO. 2025-112

A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A CONTRACT WITH NRG BUSINESS MARKETING LLC TO FURNISH NATURAL GAS AND RELATED SERVICES FOR THE CITY OF WILLOUGHBY'S PUBLIC BUILDINGS FOR A PERIOD OF FOUR (4) YEARS, EFFECTIVE DECEMBER 1, 2025, AND DECLARING AN EMERGENCY.

WHEREAS, In May, 2025, the Mayor was authorized to review and accept the best pricing and time period proposed by a retail natural gas supplier for purchase of natural gas and related services for the subsequent inclusion within an agreement for purchase of natural gas and related services for the City of Willoughby's public buildings for a period of twelve (12) to forty-eight (48) months, starting December 1, 2025; and

WHEREAS, the Director of Public Service received a proposal for a four (4) year period commencing on December 1, 2025, which would be financially beneficial to the City; and

WHEREAS, Council has determined that it would be in the best interest of the City to enter into a contract with NRG Business Marketing LLC for the furnishing of natural gas and related services for a four (4) year period;


NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WILLOUGHBY, THE COUNTY OF LAKE, AND THE STATE OF OHIO:


SECTION 1. That the Mayor is hereby authorized to enter into a contract with NRG Business Marketing LLC, 804 Carnegie Center, Princeton, NJ 08540, in the amount of \$3.915/Dth City Gate to furnish natural gas and related services for the City of Willoughby's public buildings for a period of four (4) years effective December 1, 2025; such expenditures to be made from various Funds.

SECTION 2. That the Mayor is further authorized to execute any and all additional documents and forms necessary to the implementation of said contract.

SECTION 3. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were conducted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such actions were conducted in meetings open to the public in compliance with all legal requirements including Chapter 107 of the Codified Ordinances of the City of Willoughby.

SECTION 4. That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, and welfare of the inhabitants of the community; and for the further reason to allow the best contract at current prices; and provided that it receives the affirmative vote of two-thirds of the members elected to Council, it shall be in full force and take effect immediately upon its adoption by Council and approval by the Mayor; otherwise, it shall be in full force and take effect from and after the earliest period allowed by law.
