

**RESOLUTION NO. 2025-125**

**A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A CONTRACT WITH ATLANTIC EMERGENCY SOLUTIONS, INC. IN AN AMOUNT NOT TO EXCEED \$415,000 FOR THE PURCHASE OF ONE (1) HORTON MEDICAL UNIT, 2027 FORD F550 XLT DIESEL 4 X 4, MODEL 623 FOR USE BY THE WILLOUGHBY FIRE DEPARTMENT; SAID PURCHASE TO BE MADE THROUGH THE STATE OF OHIO COOPERATIVE PURCHASING PROGRAM, AND DECLARING AN EMERGENCY.**

**WHEREAS**, the Chief of Fire received a quote in the amount of \$415,000 from Atlantic Emergency Solutions, Inc. for the purchase of one (1) Horton Medical Unit, 2027 Ford F550 XLT Diesel 4 x 4, Model 623 for use by the Willoughby Fire Department; and

**WHEREAS**, it is in the best interest of the City to purchase the Horton Medical Unit, 2027 Ford F550 XLT Diesel 4 x 4, Model 623 from Atlantic Emergency Solutions, Inc. through the State of Ohio Cooperative Purchasing Program without bidding or advertising;

**THEREFORE, NOW BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WILLOUGHBY, THE COUNTY OF LAKE, AND THE STATE OF OHIO:**

**SECTION 1.** That the Mayor is hereby authorized to enter into a contract with Atlantic Emergency Solutions, Inc., 12351 Randolph Ridge Lane, Manassas, VA 20109, for the purchase of one (1) Horton Medical Unit, 2027 Ford F550 XLT Diesel 4 x 4, Model 623 in an amount not to exceed \$415,000 through the State of Ohio Cooperative Purchasing Program; said amount to be expended from the Safety Tax Levy Fund.

**SECTION 2.** That the Mayor is further authorized to execute any and all additional documents and forms necessary to the implementation of said contract.

**SECTION 3.** It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were conducted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such actions were conducted in meetings open to the public in compliance with all legal requirements including Chapter 107 of the Codified Ordinances of the City of Willoughby.

**SECTION 4.** That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, and welfare of the inhabitants of the community; and for the further reason for to be placed on the vehicle construction list as soon as possible; and provided that it receives the affirmative vote of two-thirds of the members elected to Council, it shall be in full force and take effect immediately upon its adoption by Council and approval by the Mayor; otherwise, it shall be in full force and take effect from and after the earliest period allowed by law.
