

RESOLUTION NO. 2026-87

**A RESOLUTION AUTHORIZING AN EXPENDITURE IN THE
AMOUNT OF \$14,491.25 FOR THE CONSTRUCTION OF
RESIDENTIAL SIDEWALKS IN THE CITY BY ALL WAYS
CONSTRUCTION LLC, AND DECLARING AN EMERGENCY.**

WHEREAS, a Resolution declaring it necessary to construct sidewalks at 5670 Hartshire Drive, 38125 Highgate Bluff Lane and 38135 Highgate Bluff Lane was adopted on September 9, 2025; and

WHEREAS, the City Engineer received five (5) informal bids for the construction of the certain sidewalks in the City; and

WHEREAS, the bid received from All Ways Construction, LLC in the amount of \$14,491.25 for the construction of sidewalks located at 5670 Hartshire Drive, 38125 Highgate Bluff Lane and 38135 Highgate Bluff Lane was, in the opinion of the Council of the City, the lowest and best bid received thereon; and

WHEREAS, at the completion of such construction, the costs shall be assessed against the abutting lots or lands;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WILLOUGHBY, THE COUNTY OF LAKE, AND THE STATE OF OHIO:

SECTION 1. That an expenditure in the amount of \$14,491.25 for the construction of sidewalks at 5670 Hartshire Drive, 38125 Highgate Bluff Lane and 38135 Highgate Bluff Lane in the City is hereby approved and the City Engineer is authorized to proceed with such construction by All Ways Construction, LLC, 11938 Mayfield Rd., Chardon, OH 44024; said amount to be expended from the Corporate Maintenance Fund.

SECTION 2. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were conducted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such actions were conducted in meetings open to the public in compliance with all legal requirements including Chapter 107 of the Codified Ordinances of the City of Willoughby.

SECTION 3. That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, and welfare of the inhabitants of the community; and for the further reason to proceed in a timely manner; and provided that it receives the affirmative vote of two-thirds of the members elected to Council, it shall be in full force and take effect immediately upon its adoption by Council and approval by the Mayor; otherwise, it shall be in full force and take effect from and after the earliest period allowed by law.

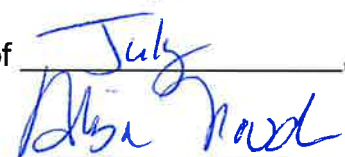
