

RESOLUTION NO. 2026-102

A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A CONTRACT WITH RONYAK PAVING, INC. IN THE AMOUNT OF \$720,720 FOR IMPLEMENTATION OF THE 2026 PAVEMENT REPAIR PROGRAM, AND DECLARING AN EMERGENCY.

WHEREAS, on the 5th day of August, 2026, bids were received by the City Engineer for the 2026 Pavement Repair Program; and

WHEREAS, the bid received from Ronyak Paving, Inc. was, in the opinion of the Council of the City, the lowest and best bid received thereon;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WILLOUGHBY, THE COUNTY OF LAKE, AND THE STATE OF OHIO:

SECTION 1. That the Mayor is hereby authorized to enter into a contract with Ronyak Paving, Inc., 14376 N. Cheshire St., Burton, OH 44021 in the amount of \$720,720 for implementation of the 2026 Pavement Repair Program, in accordance with the specifications and bid submitted; said amount to be expended from the Road and Bridge Fund.

SECTION 2. That the Mayor is further authorized to execute any and all additional documents and forms necessary to the implementation of said contract.

SECTION 3. That the Director of Finance, or her designee, is hereby authorized to return bid bonds, certified checks, security deposits, or letters of credit held by her to all except the three (3) lowest and best bidders. The bid deposits for the three (3) lowest and best bidders shall be returned upon execution of the contract.

SECTION 4. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were conducted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such actions were conducted in meetings open to the public in compliance with all legal requirements including Chapter 107 of the Codified Ordinances of the City of Willoughby.

SECTION 5. That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, and welfare of the inhabitants of the community; and for the further reason of time constraints; and provided that it receives the affirmative vote of two-thirds of the members elected to Council, it shall be in full force and take effect immediately upon its adoption by Council and approval by the Mayor; otherwise, it shall be in full force and take effect from and after the earliest period allowed by law.
